Collection under law	We may be required to collect personal information under the <i>Telecommunications Act 1997</i> and laws made under it (eg if we supply a pre-paid public mobile telecommunications service, we are required by law to carry out an identity check.) We may be required to collect information, relating to an individual or a communication to which an individual is a party, under the 'data retention' provisions of the <i>Telecommunications (interception and</i> <i>Access) Act 1979</i> ('Data Retention Law').
Why we collect and hold personal	We collect and hold personal information because:

Unavailability of personal information	If we cannot collect the information we need about you, we may not be able to supply the products or service you want.
Disclosing personal information	We may disclose personal information as reasonably required to contractors and suppliers who goods and services that we use to operate our business and provide products and support to you, and to other parties detailed in our Privacy Policy. We may also disclose it to authorised agencies under the Data Retention Law.
Access and correction	Our privacy policy contains information about how you can access and seek correction of the personal information about you that we hold.
Complaints	Our privacy policy explains how you can complain about a breach of the Australian Privacy Principles, and how we will deal with such a complaint.
